HISTORY OF CITIZENS ADVISORY COMMITTEE



The Citizens Advisory Committee (CAC) was first created in 2016 to help the District navigate the rapidly declining enrollment projected to occur at Lynbrook High School.

In 2017, the CAC recommended a new transfer program that would help stabilize enrollment at Lynbrook. The plan became known as the Lynbrook Supplemental School Assignment Plan (LSSAP) and was approved by the Board of Trustees in 2017 for implementation in the 2017-18 school year.

HISTORY OF THE LSSAP



The LSSAP would allow for students attending Miller Middle School and McAuliffe Middle School to attend Lynbrook High School, regardless of their resident FUHSD High School. It would also allow students living in Hyde Middle School attendance area to request to attend LHS based upon transfer spots available.

The plan was short term, flexible and aimed at moving students from a large school, the Cupertino High School attendance area to Lynbrook High School.

HISTORY OF THE LSSAP



Since the initial one-year approval of the LSSAP, the CAC has continued to meet and recommended continuing the LSSAP for 6 consecutive years.

The CAC has met three times this year and examined data that supports a recommendation to continue the LSSAP for two additional years.

HISTORY OF MVHS TRANSFER PROGRAM



In 2023, the Board of Trustees approved the first implementation of the Monta Vista Supplemental School Assignment Plan (MSSAP) for the **2023-24 school year.**

The approval was based on the recommendation of the Citizens Advisory Committee (CAC), in order to provide some short-term enrollment stabilization for Monta Vista High School.

The MSSAP allowed for incoming 9th Grade students living in the Homestead attendance area, to attend Monta Vista High School.

Additional Information:

- Goal of 30 transfers
- 6 additional students were accepted, but declined
- 5 additional students were accepted but did not show up to start the year
- Of the 11 denials/no shows, 4 were from Cupertino MS and 7 were from private school

MONTA VISTA TRANSFER PROGRAM SUGGESTIONS



Though the MSSAP did not meet the initial goal of 30 transfers from HHS attendance are, the CAC recommends continuing the program.

The CAC acknowledges that the MSAAP was approved later in the school year, so less promotion was done compared to the original LSSAP.

The CAC provided input into ways to improve communication, increase student/parent interest and ultimately meet the transfer goal of 30 students.

MONTA VISTA TRANSFER PROGRAM SUGGESTIONS



CAC suggestions to increase the number of applications:

1. Diversify communication strategies

- a. Increase use of Social Media
- b. Use Middle School communication opportunities
- c. Provide student created videos about MVHS
- d. Email from HHS and MVHS to parents/students
- e. Use High School communication opportunities

1. Increase and diversity activities/opportunities for parents and students to learn more about MVHS

- a. MVHS Information Night for HHS parents/students
- b. Provide a shadow day for interested students
- c. Create opportunities for MVHS Students to promote their school instead of adults




RESIDENT ENROLLMENT DISPARITY BETWEEN LARGEST AND SMALLEST SCHOOLS


<u>ATTENDING</u> ENROLLMENT DISPARITY BETWEEN LARGEST AND SMALLEST SCHOOLS

SUPPORTING DATA - RESIDENT ENROLLMENT


